
Summary

As communicated to St. Cecilia families on June 28, 2023, the Board of Trustees has directed staff to review the secondary school feeder alignment for the **St. Cecilia CES** community.

The secondary boundary review process is underway. The Local Boundary Review Committee (consisting of the school principals, school superintendents, the local Trustee, Planning Services staff and Student Transportation Services staff) is hosting a Public Information Session for all stakeholders in the St. Cecilia school community.

The Public Information session is on **Wednesday September 27, 2023 from 6:30 – 8:00 pm at St. Cecilia CES** (300 Peter Rupert Avenue, Vaughan, ON).

At the April 24, 2023 Board of Trustee meeting, the Board of Trustees passed the following motion:

"That a review of the secondary boundaries for St. Joan of Arc CHS and St. Elizabeth CHS be reviewed with respect to the alignment of the St. Cecilia CES community by the fall of 2023 with any possible changes effective September 2024."

The goal of this review is to respond to shifts in enrolment patterns and trends within the area. All families in the school community are invited to attend the information session.

The meeting will take the form of a "drop-in" open house session, and you are welcome to arrive at any time. There will be a number of map displays and other display boards with relevant information and various options for review and consideration.
